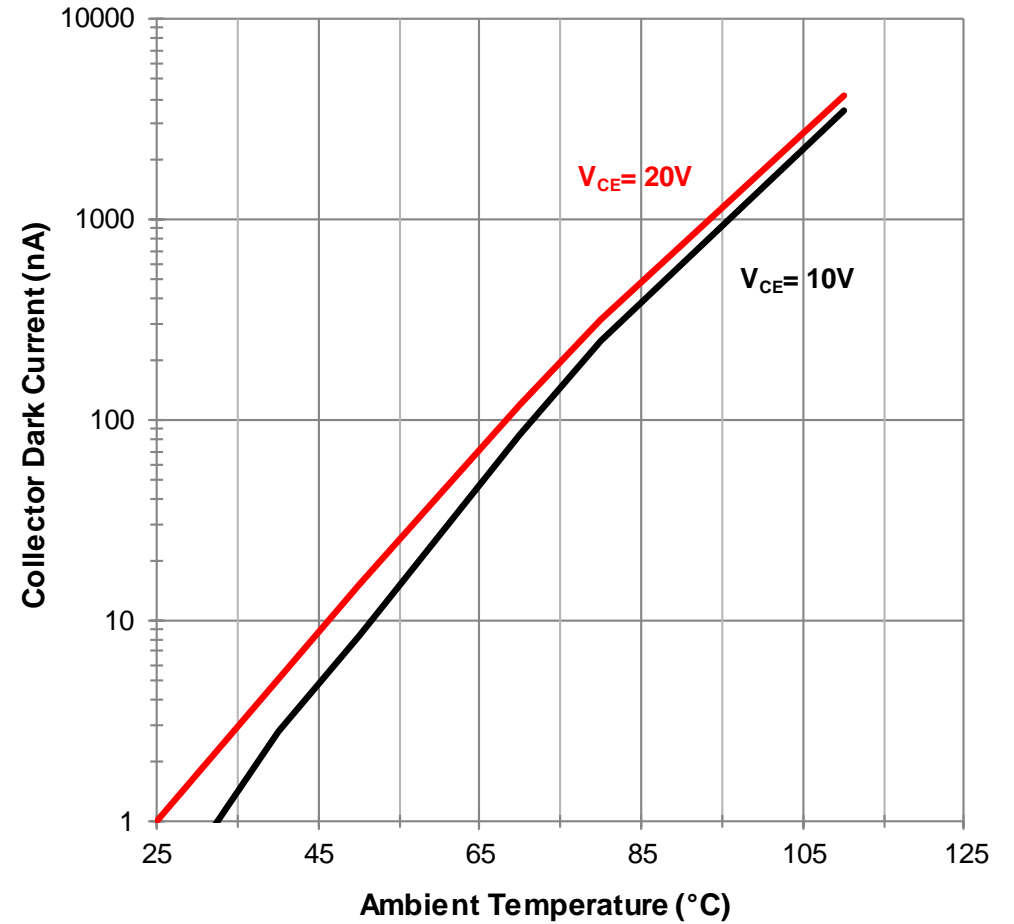

### Collector-Emitter Saturation Voltage vs. Ambient Temperature:

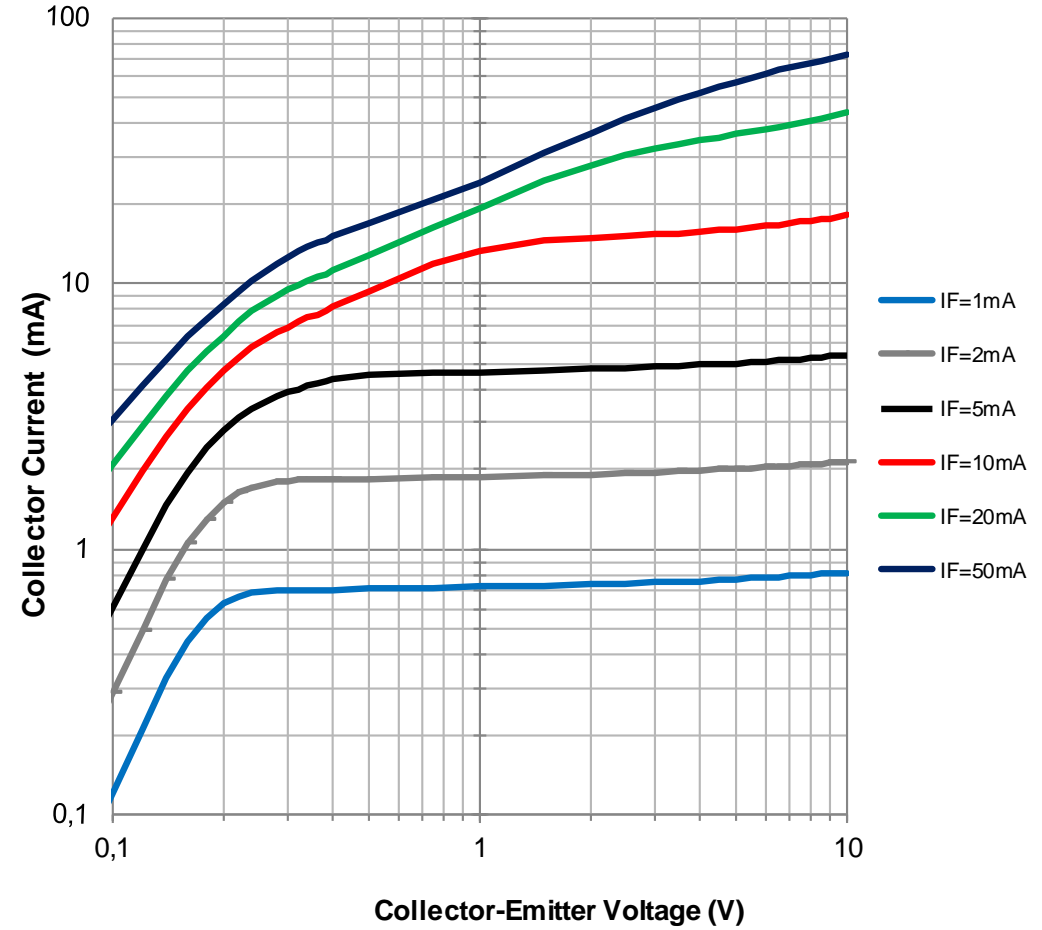

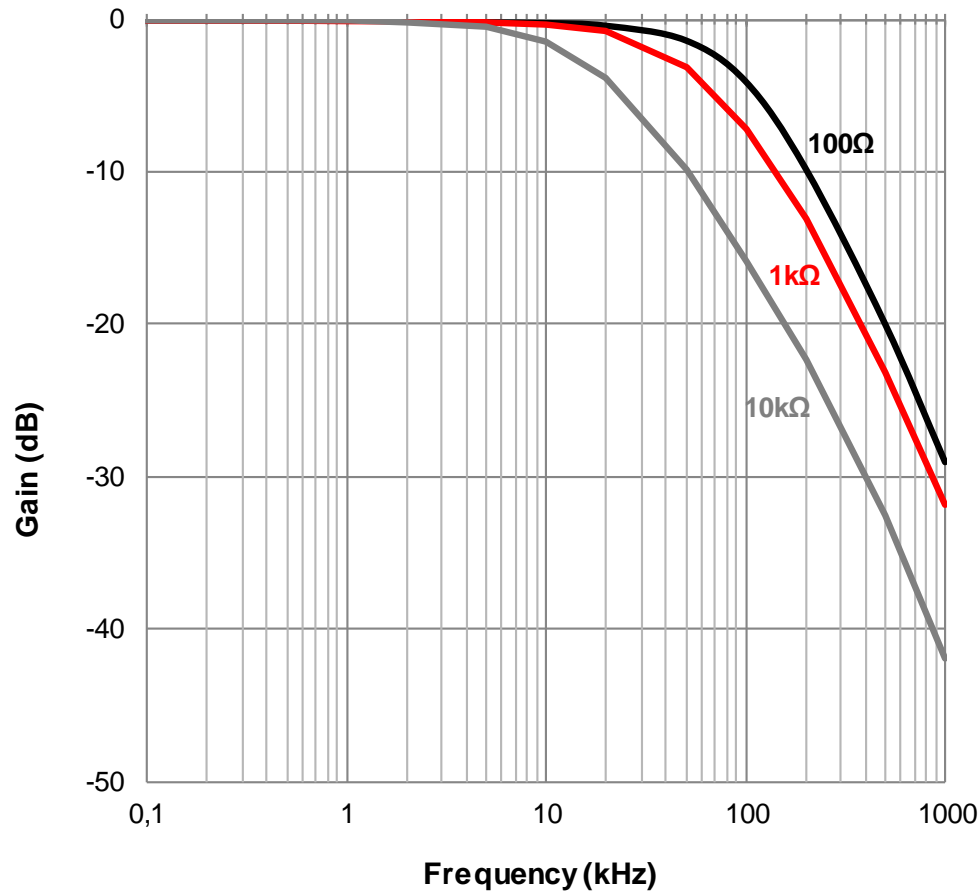
### Switching time vs. Load Resistance:

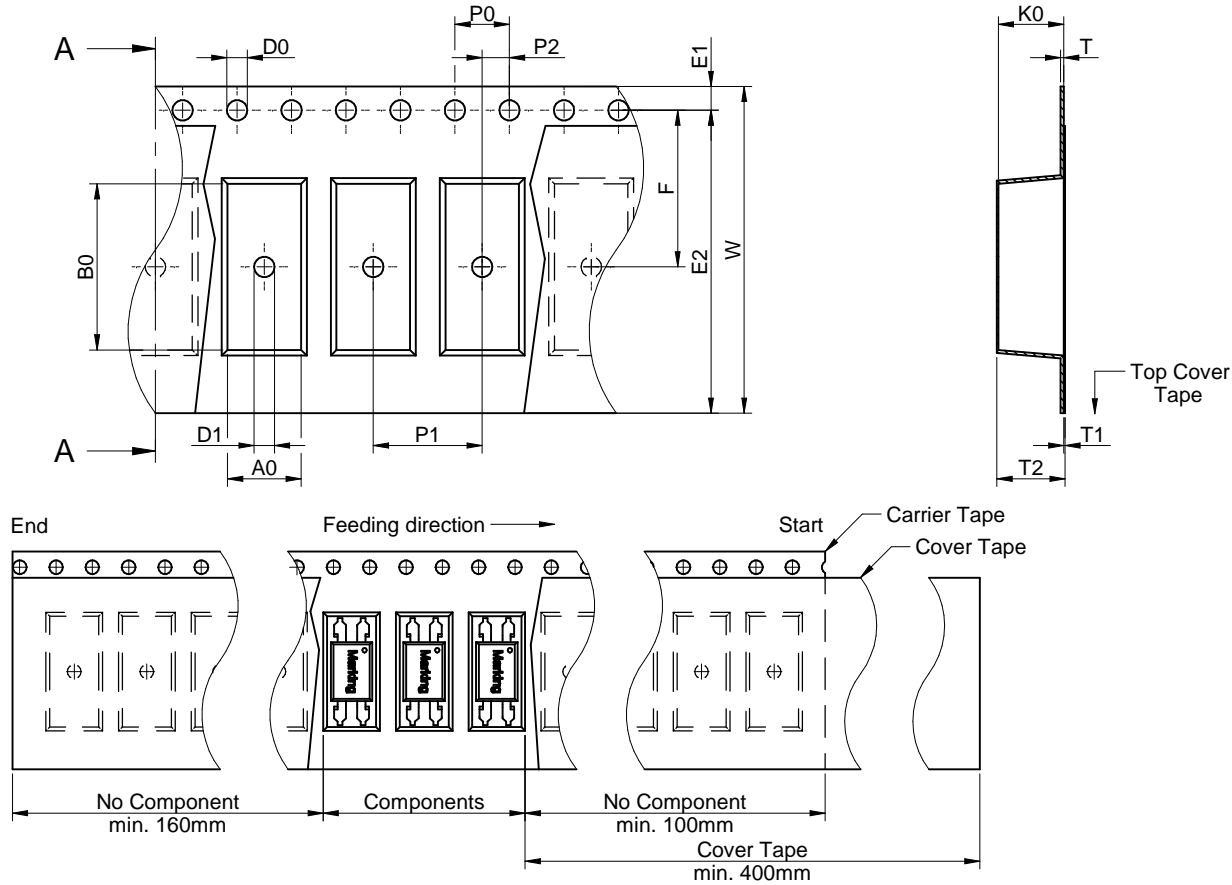

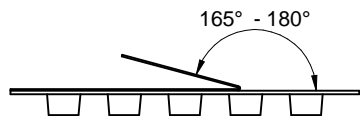

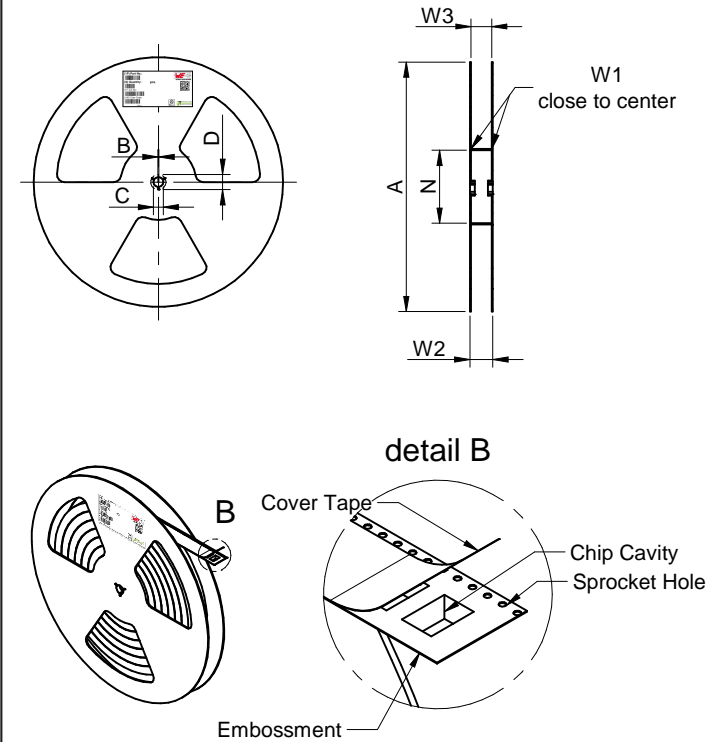

#### Soldering:






