**To eliminate Laser marking of Shunt resistor PU3921—implementation date: Feb 8th, 2023**



This notification is to inform you that YAGEO will eliminate the resistance value marking on the PU3921 for the purposes of reducing environmental risks and ecological scarcities for environmental protections. To identify the product resistance value each single reel is labeled with all relevant data and will continue serving the purposes. There will be no impact to the product's performance, features and specifications. The no resistance marking of PU3921 has been qualified and validated consistent with existing product specification.

YAGEO has provided no resistance marking on Shunt resistor PU2512 and PU5931. YAGEO continuously focus on variation reduction and production availability improvement. We believe that eliminating the marking on the PU3921 lead to longer term prospects for productivity improvements.

After the implementation date, the PU3921 will be manufactured without marking. During the transition period, customers may receive shipments of either pre-change or post-change product. There will be a short period of time that both types of the products, with marking and without marking, exist simultaneously in the market.


