Typical Insertion Loss:



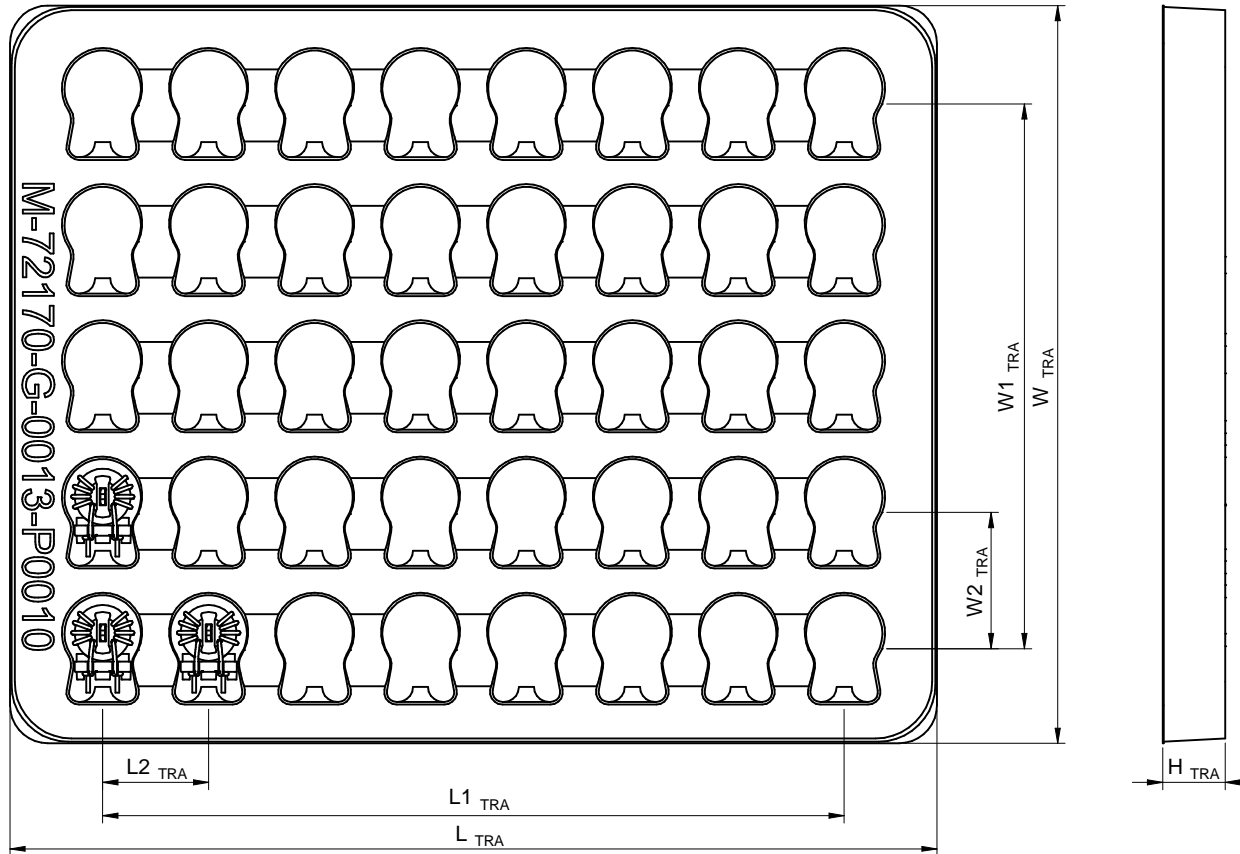

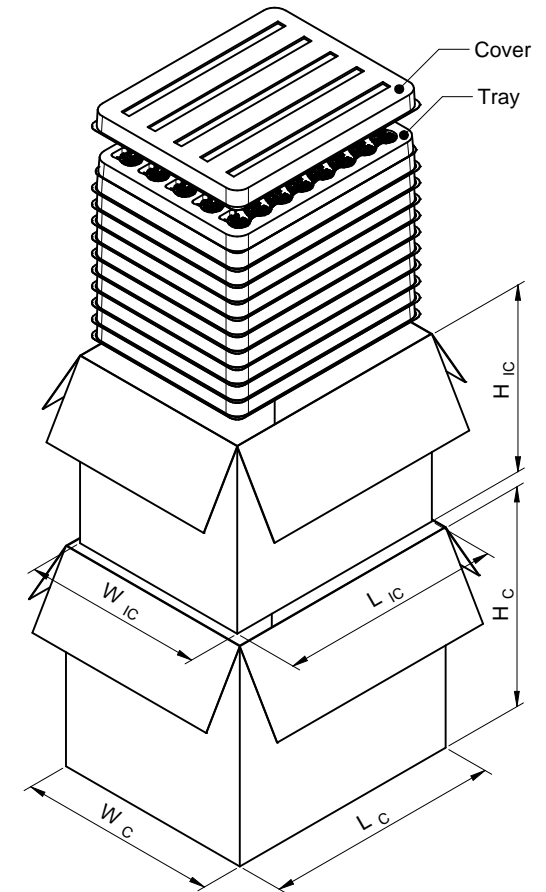

Soldering



Storage Conditions:


