**General Product Description:**

Spec 44 and FLDW Wires

**Description of Changes**

TE Connectivity was informed by one of its material supplier on a consolidation in their manufacturing plant for PVDF based Color Concentrates (CC). TE Wire and Cable plants in Tijuana and Redwood City use PVDF CCs as colorant for outer insulation layer in spec 44 and FLDW primary wires. TE has evaluated the PVDF CCs from the supplier's new manufacturing location and no change to Form, Fit and Function of finished parts has been observed.

**Reason for Changes:**

Part status change. TE was notified by its material supplier that except for Black PVDF CC, no change has been made in material formulation and recipe for PVDF CCs produced from their new manufacturing site. Due to health and safety policy of vendor's new manufacturing site with respect to handling raw carbon black pigments, this CC has undergone a change of one raw material component. TE evaluated these changes on the key characteristics of the CCs and the finished goods and no impact on the properties and performance of finished parts has been observed. Test reports on the wire characteristics can be provided upon request. In addition to the evaluation conducted by TE, FAIs will be performed on the first manufactured primary wire lot per each gauge for validation.
