Description for Product Change Notification

To optimize the PTV series, the PTV 2.5 portfolio will receive a small modification on the pusher to improve operation of the terminal block. The bridging channel has also been optimized, changing from a stamped hole to a rim hole. The technical data nor function of the bridging channel is changed, and is completely functional with the current bridge design. The new PTV 2.5 design will require new end covers, and the old versions will be discontinued later this year. Please see the attached table for more information.
