Announcement of Suspending Shipments for Specific Products Due to New EPA Regulations

Dear Valued Channel Partner,

We regret to inform you that we will need to suspend shipments for the products listed below due to a new TSCA compliance issue.

1. Background

The US/TSCA (Toxic Substances Conrtrol Act) Article 6 (h) PBT (persistent, bioaccumulative and toxic) regulation prohibits the export and distribution of certain products to the US if said products are in violation of the regulation.

We are working on the re-design of the products in question to satisfy the newly imposed guidelines.

Regulatory authority: United States Environmental Protection Agency (EPA) Announcement date: January 7th, 2021 Date of issue: February 5th, 2021 Enforcement date: March 9th, 2021 → Postponed for 180 days (new date: September 5th)

EPA (U.S. Environmental Protection Agency) announces mitigation measures.

- PIP(3:1) postpone enforcement of regulations for 180 days (September 5th)
- Conduct public comments on the five PBT substances and decide on mitigation measures (under discussion)
