Description of Changes

This PCN cancels PCN P-14-010877 that was issued 17Dec14 due to incorrect p/n's being listed. Description of this PCN is: Change Eurocard Type F & G contact area finish from: 1.25um gold to "Contact area finish conforms to the performance level 1 requirements of IEC 60603-2.", 0.8um gold to "Contact area finish conforms to the performance level 2 requirements of IEC 60603-2.", 0.4um gold to "Contact area finish conforms to the performance level 3 requirements of IEC 60603-2." Part numbers with gold thicknesses greater than 1.25um will remain plating specific.

Reason for Changes:

New specification. TE Connectivity is revising the connector finish specifications to align with current industry standards for separable electrical connector performance as defined within IEC 60603-2
