Bi-directional ESD protection device, 3.3 V, 30 pF, 01005



Product description

This Infineon ESD (electrostatic discharge) protection device has a bi-directional and symmetric I/V characteristic with excellent clamping performance.

Feature list

- ESD / transient protection according to:
 - IEC61000-4-2 (ESD): ± 29 kV (air) / ± 26 kV (contact)
 - IEC61000-4-4 (EFT): ± 3 kV / ± 60 A (5/50 ns)
 - IEC61000-4-5 (Surge): ± 8 A (8/20 μ s)
- Bi-directional maximum working voltage: $V_{WM} = \pm 3.3$ V
- Line capacitance: $C_L = 30$ pF (typical) at $f = 1$ MHz
- Clamping voltage: $V_{cl} = 5.6$ V (typical) at $I_{TLP} = 16$ A with $R_{dyn} = 0.06 \Omega$
- Very low leakage current: $I_L < 1$ nA (typical)
- Small form factor SMD size 01005, low profile (0.43 x 0.23 x 0.15 mm³)

- Human digital interfaces, buttons, GPIO

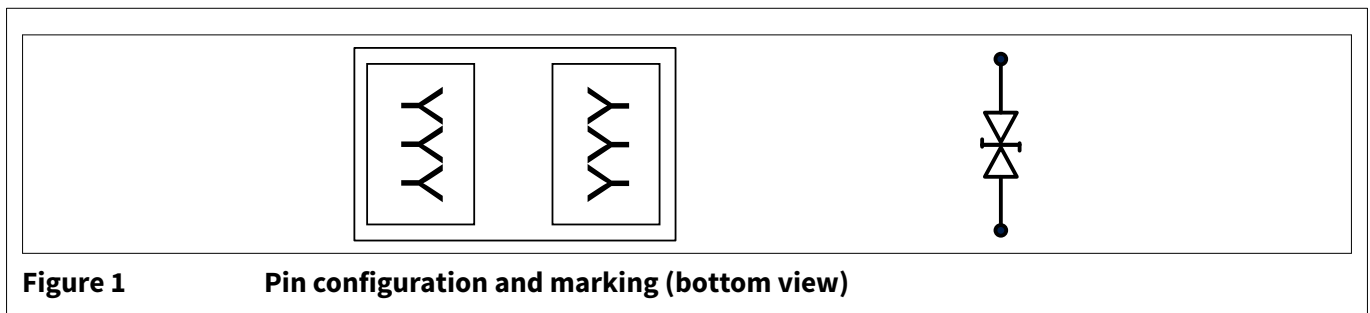

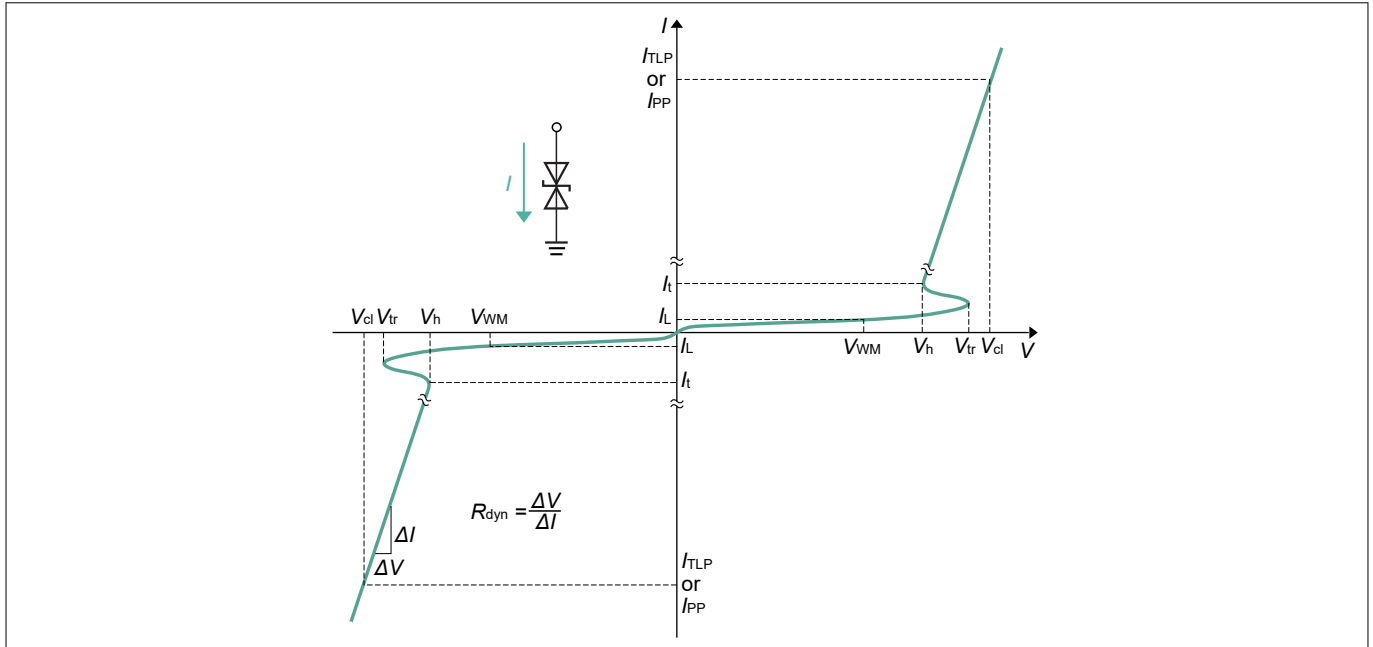


Figure 2 Definitions of electrical characteristics

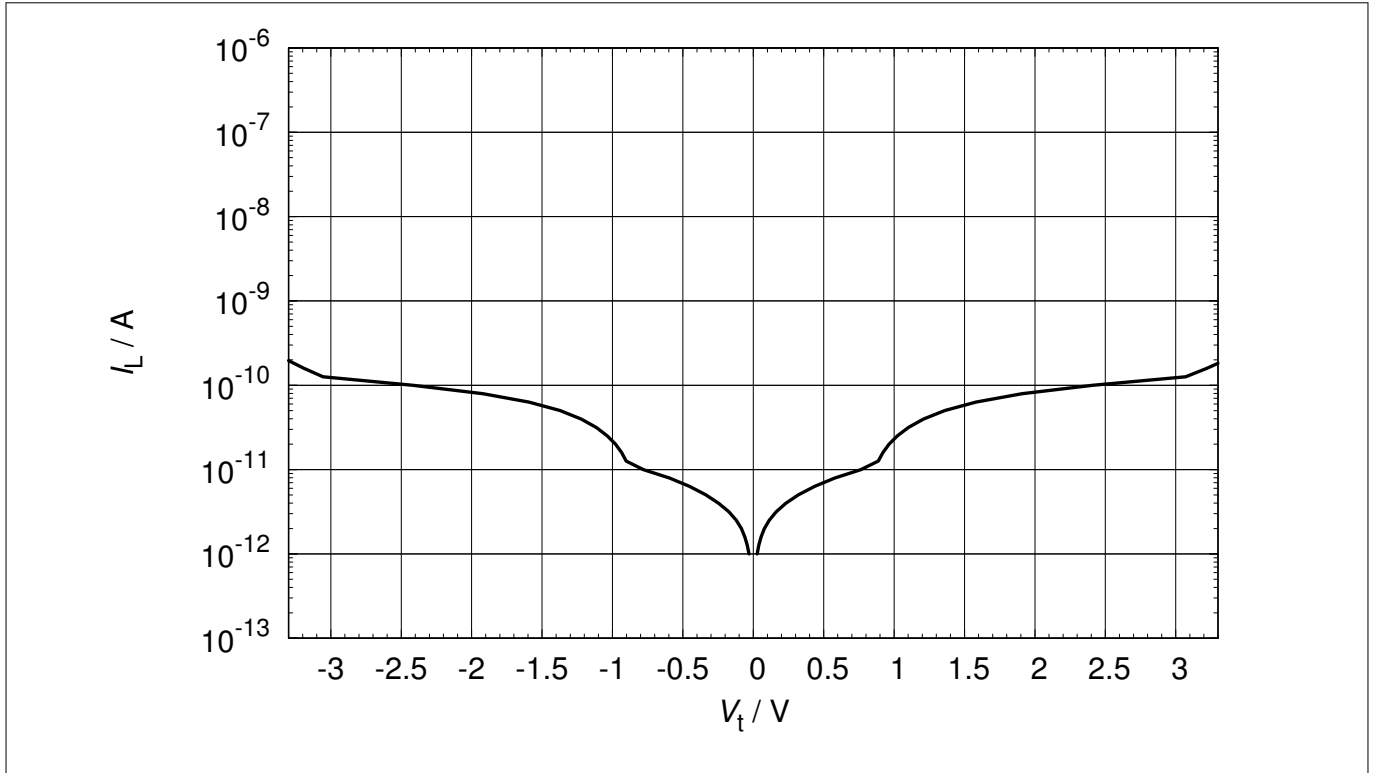


Figure 3 Leakage current: $I_L = f(V_t)$

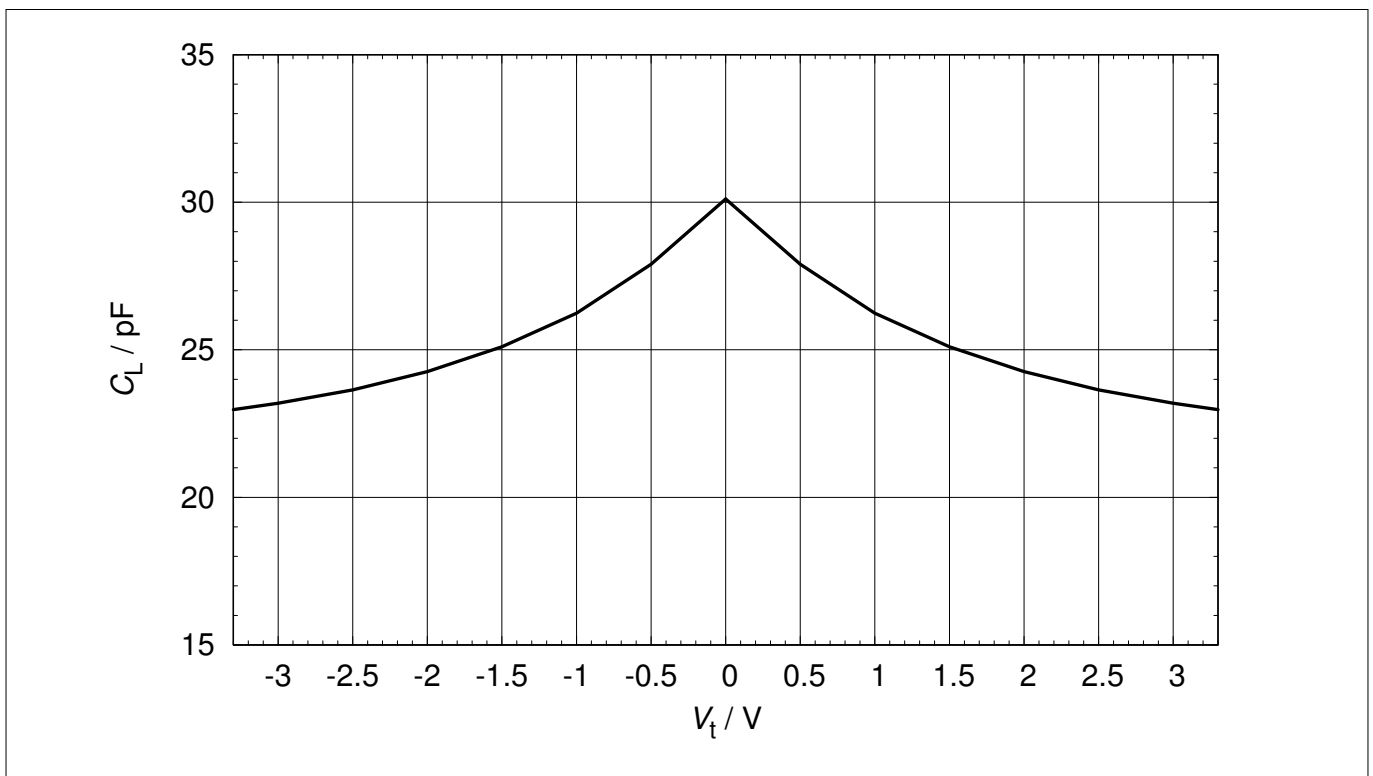


Figure 4 Line capacitance: $C_L = f(V_t)$, $f = 1\text{ MHz}$

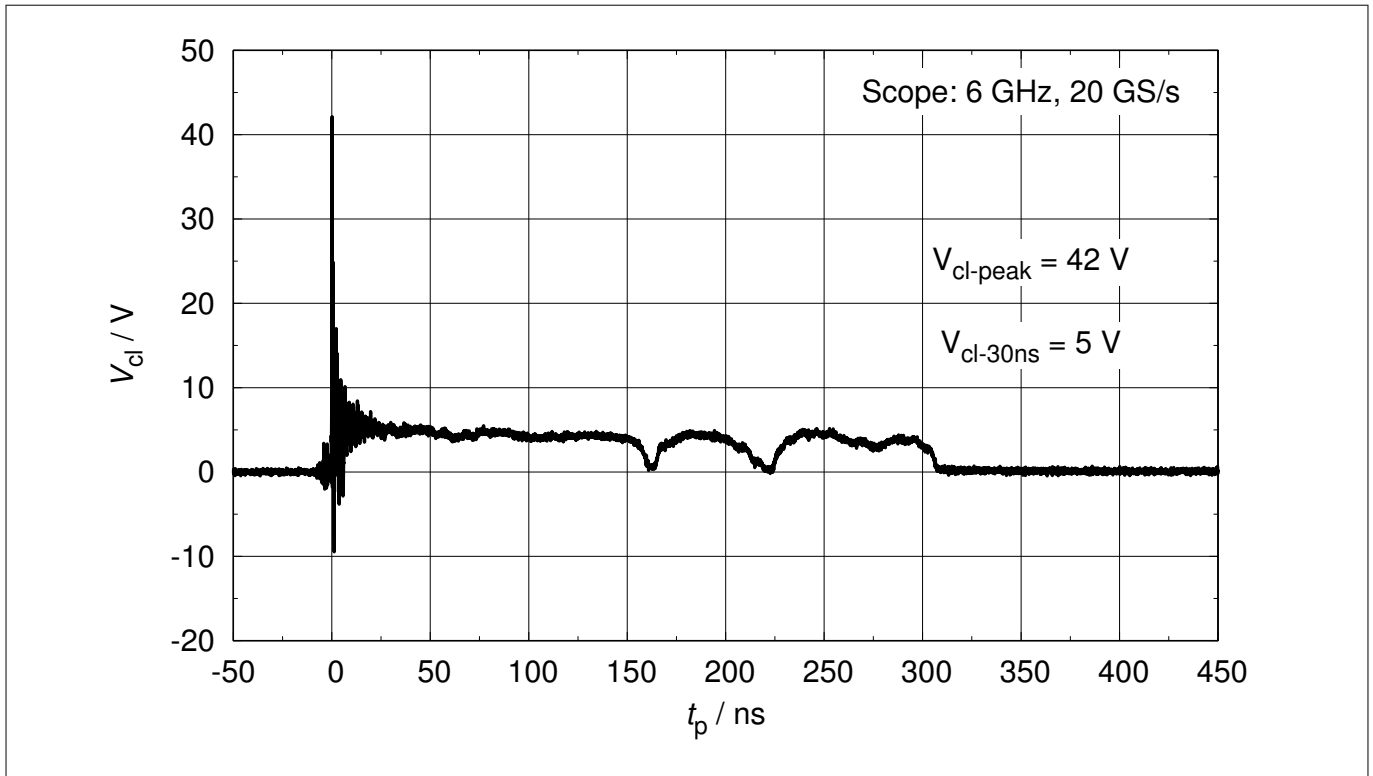


Figure 5 Clamping voltage (ESD): $V_{cl} = f(t_p)$, 8 kV positive pulse based on IEC61000-4-2

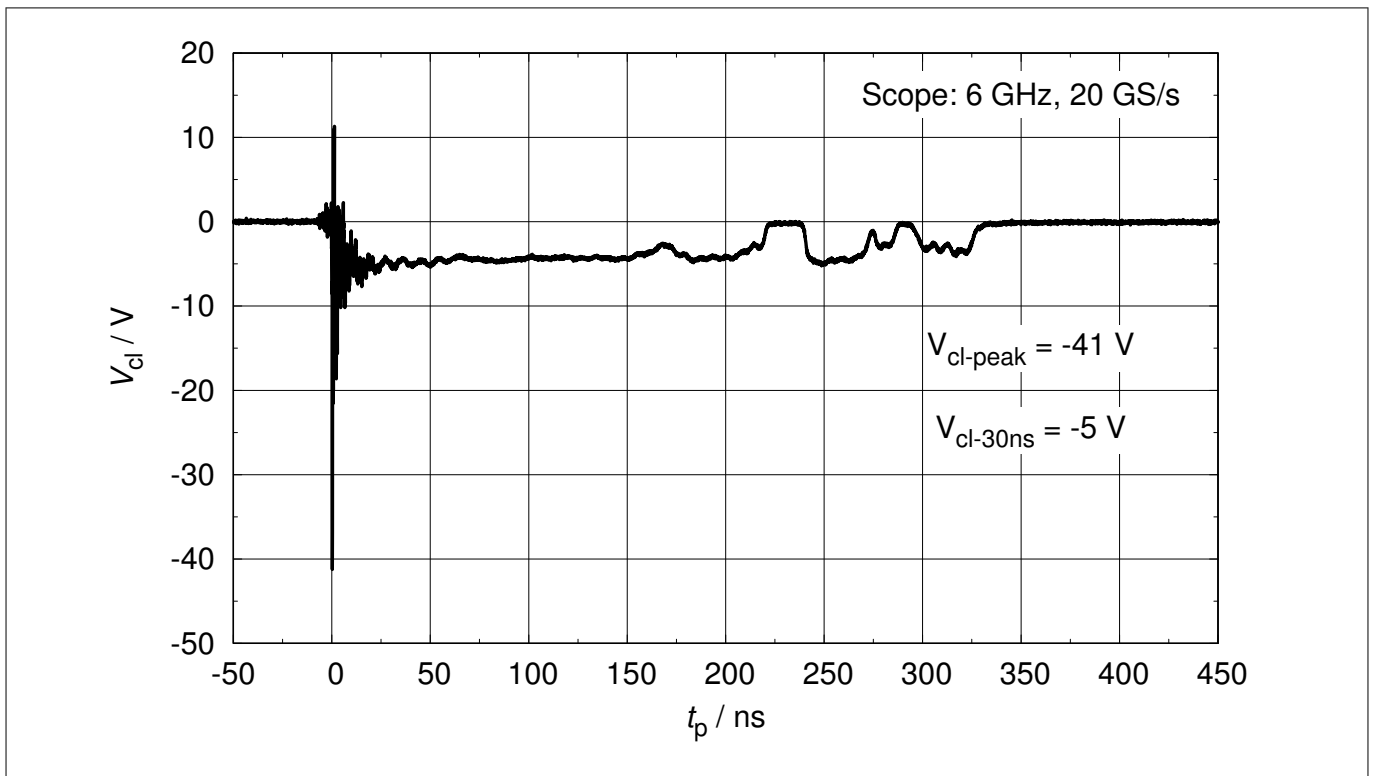


Figure 6 Clamping voltage (ESD): $V_{cl} = f(t_p)$, 8 kV negative pulse based on IEC61000-4-2

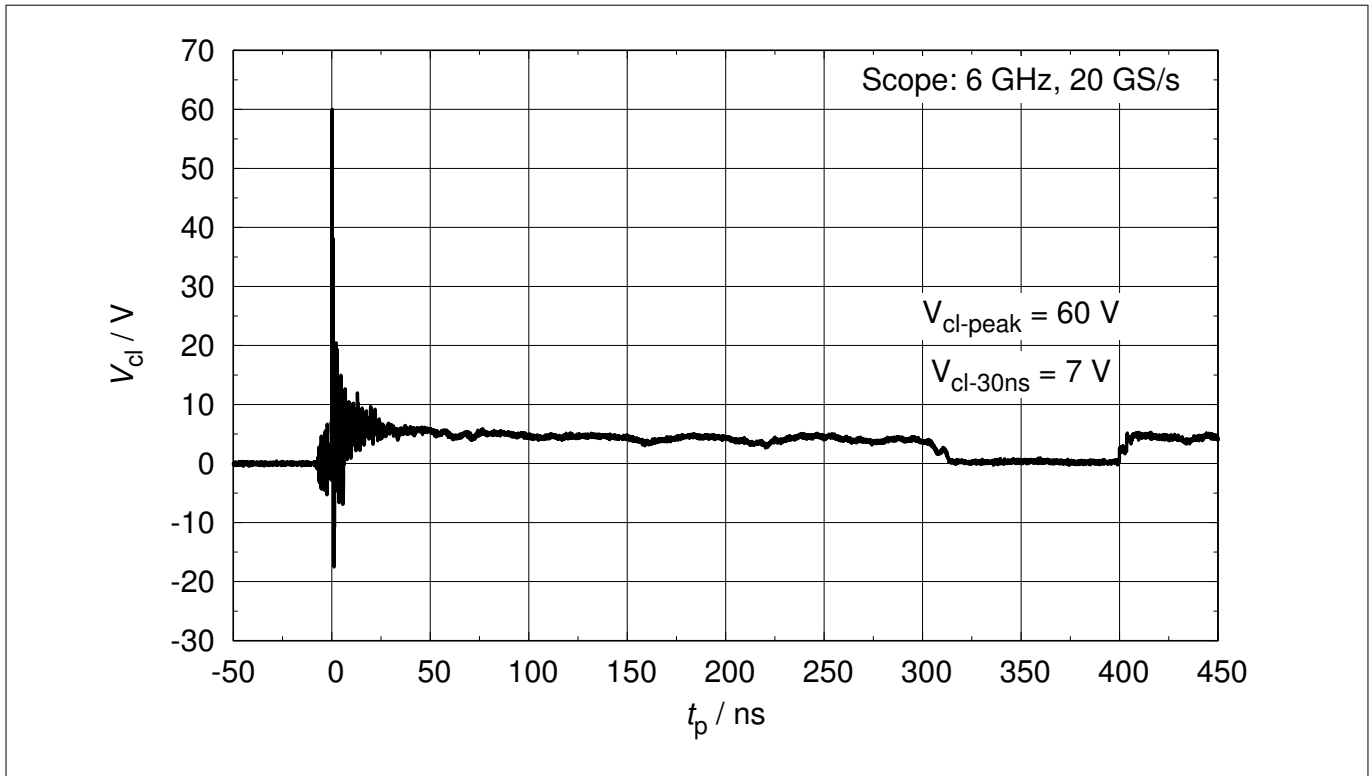


Figure 7 Clamping voltage (ESD): $V_{cl} = f(t_p)$, 15 kV positive pulse based on IEC61000-4-2

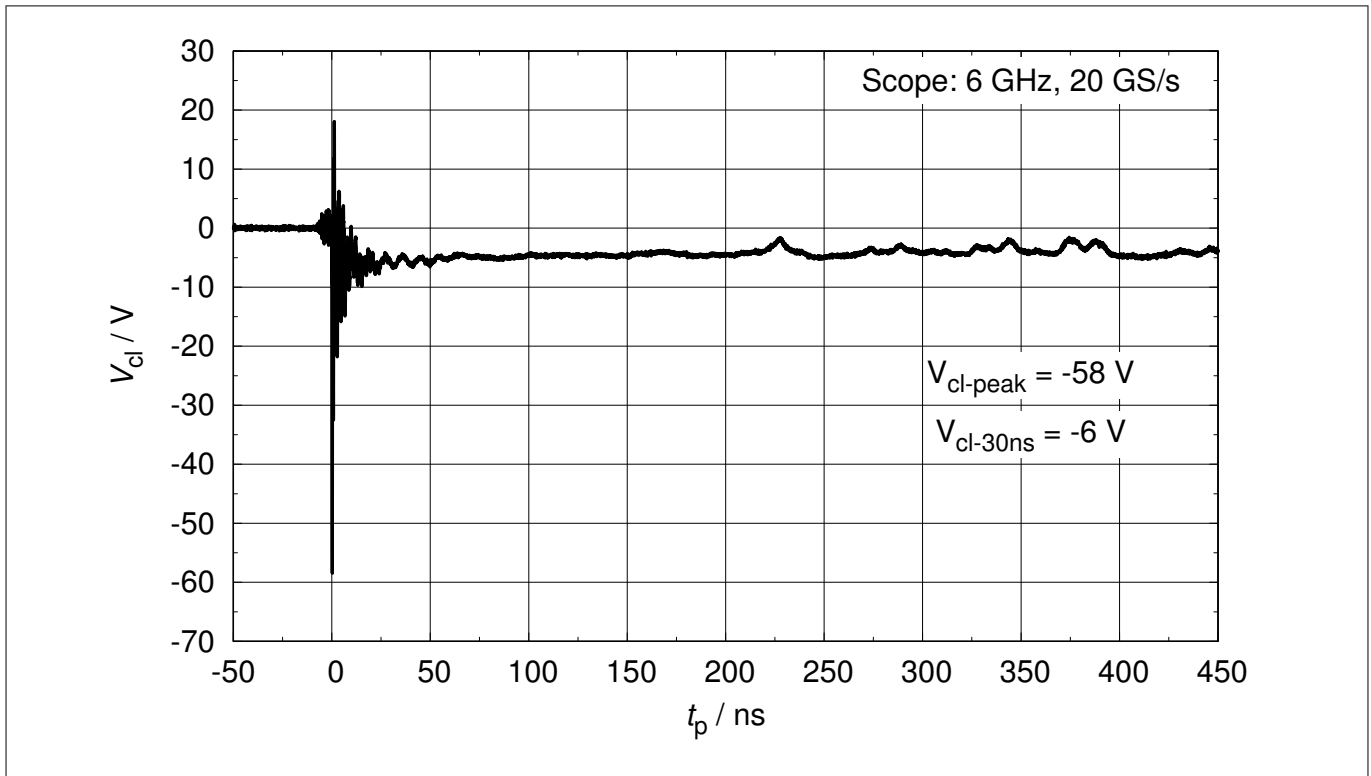


Figure 8 Clamping voltage (ESD): $V_{cl} = f(t_p)$, 15 kV negative pulse based on IEC61000-4-2

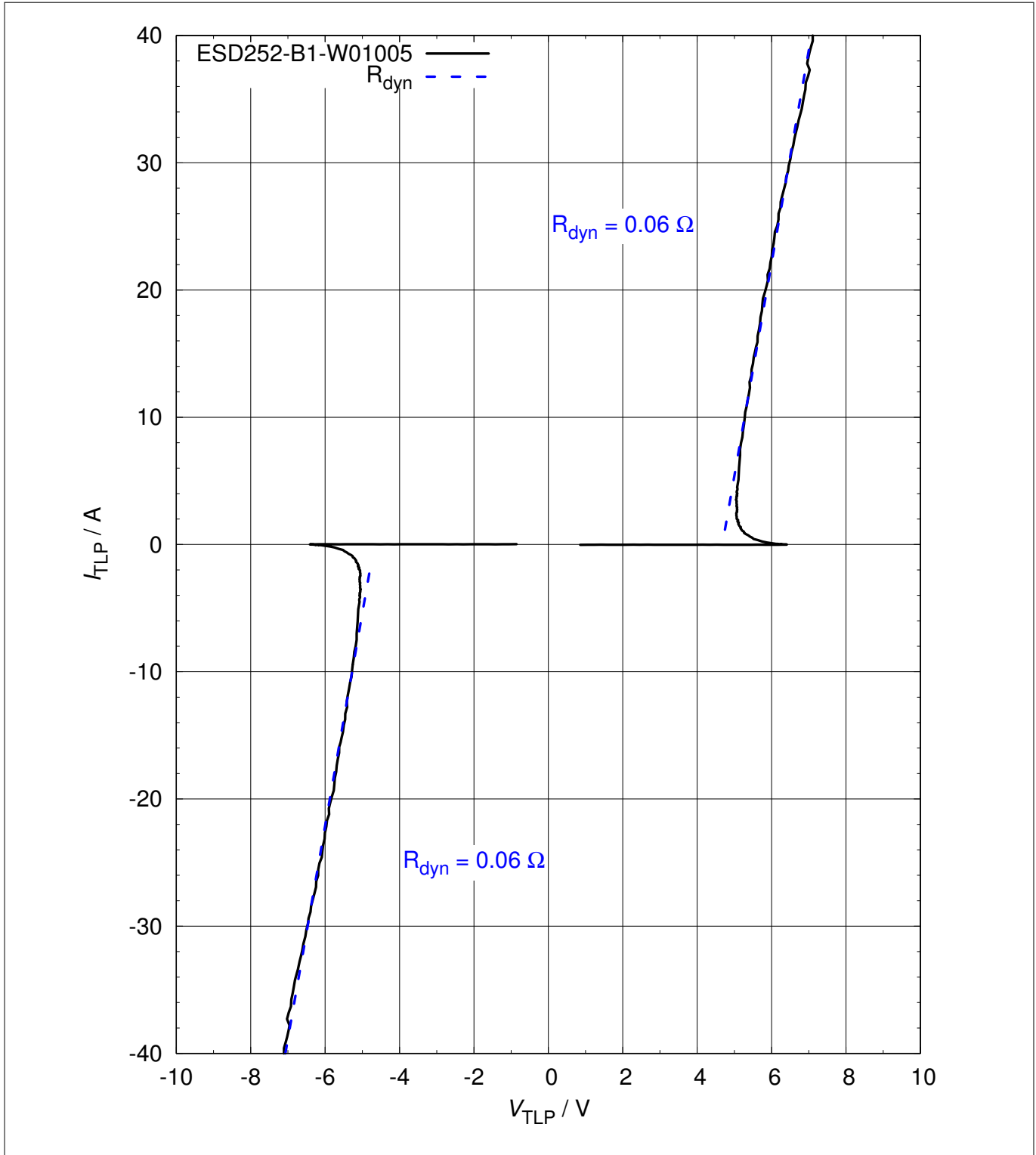


Figure 9 Clamping voltage (TLP): $I_{TLP} = f(V_{TLP})$

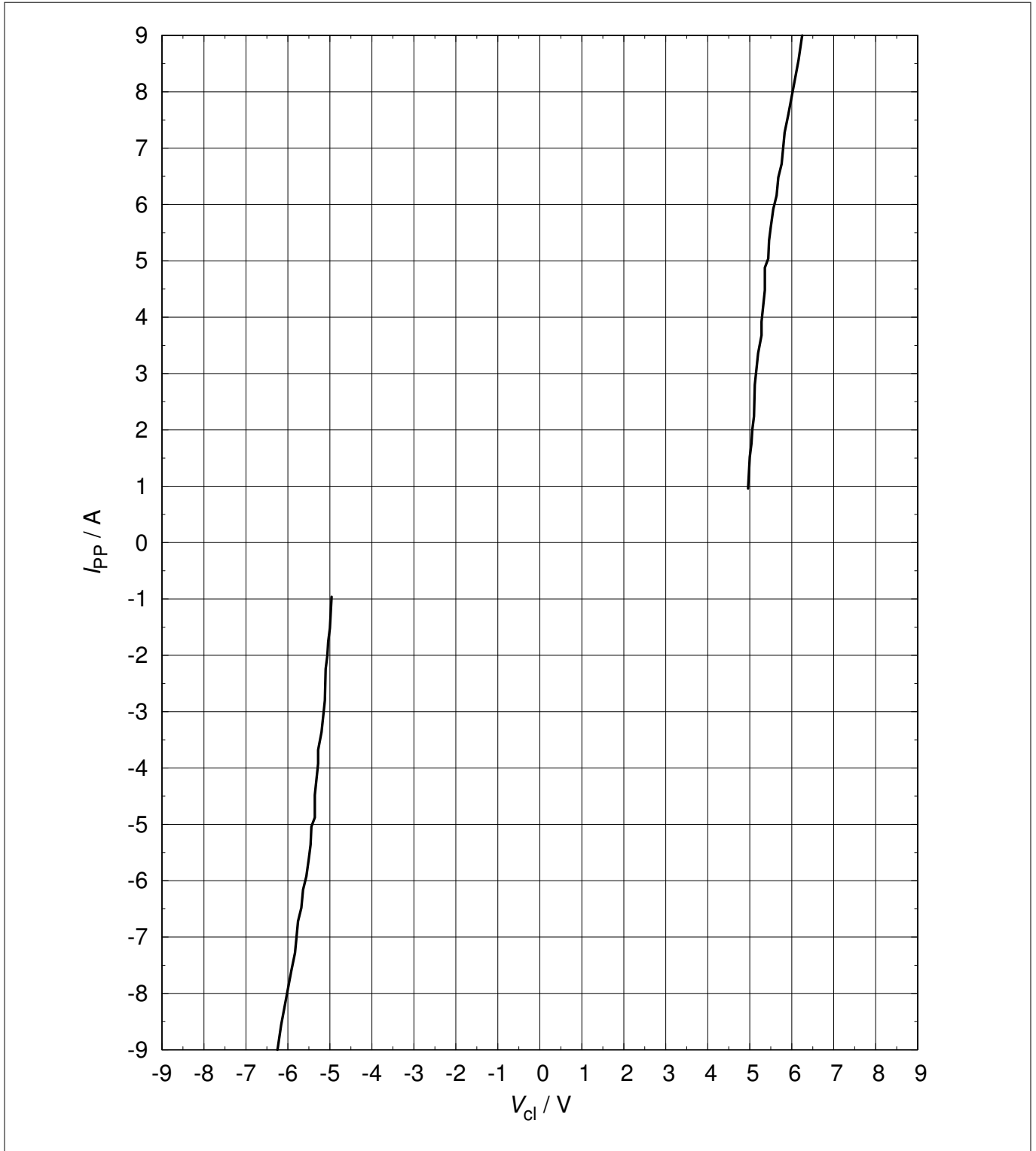


Figure 10 Clamping voltage (Surge): $I_{PP} = f(V_{Cl})$, based on IEC61000-4-5

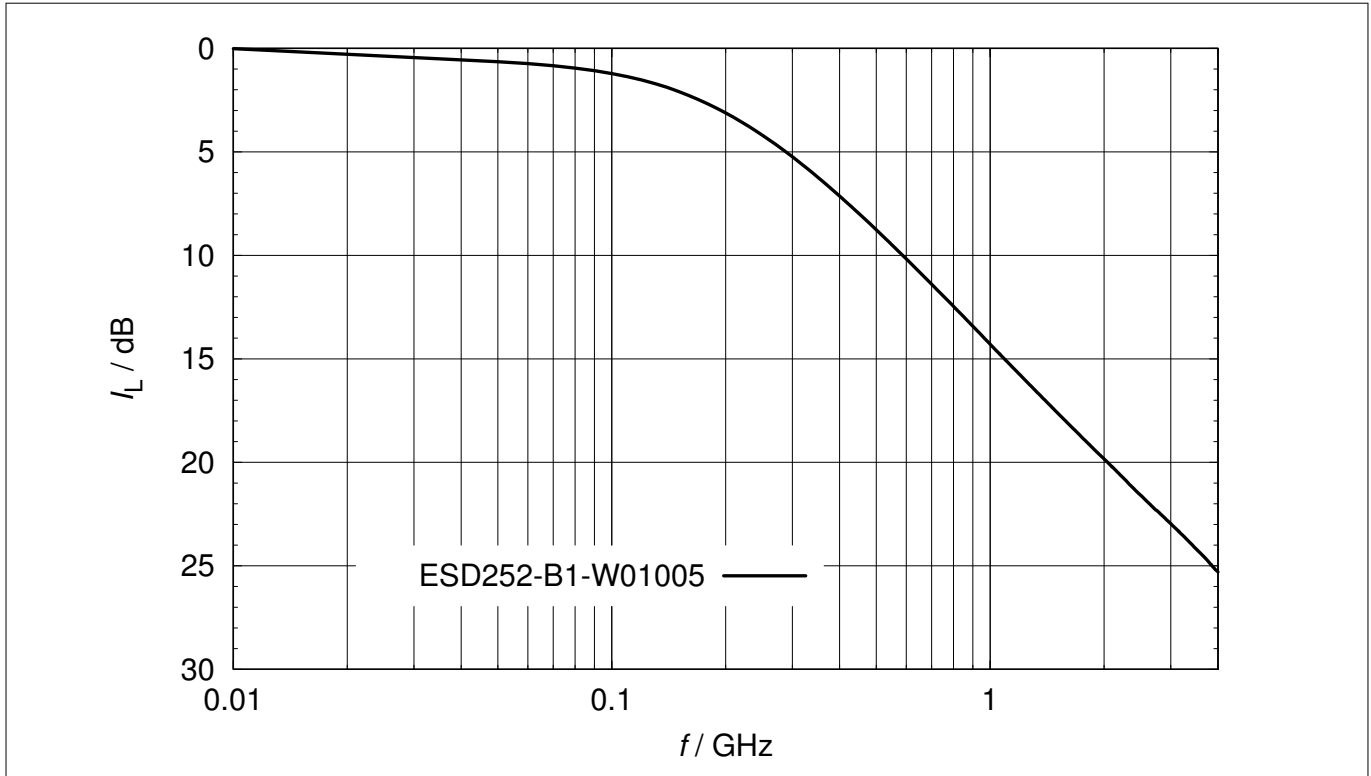


Figure 11 Insertion loss $IL = f(f)$, measured in a 50 Ω system

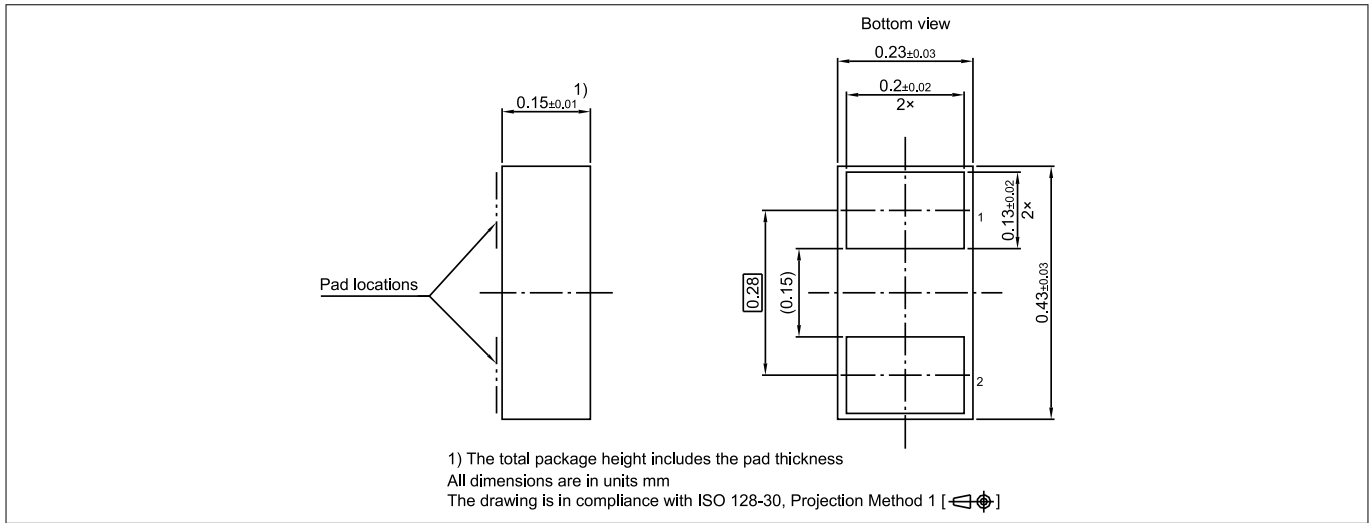


Figure 12 Package outline
