Differential Mode

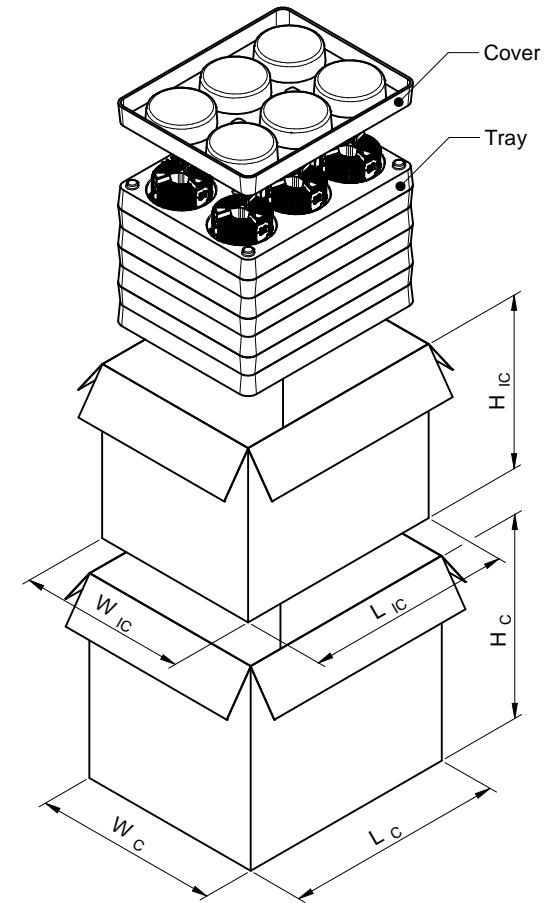
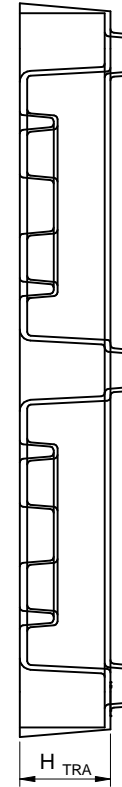
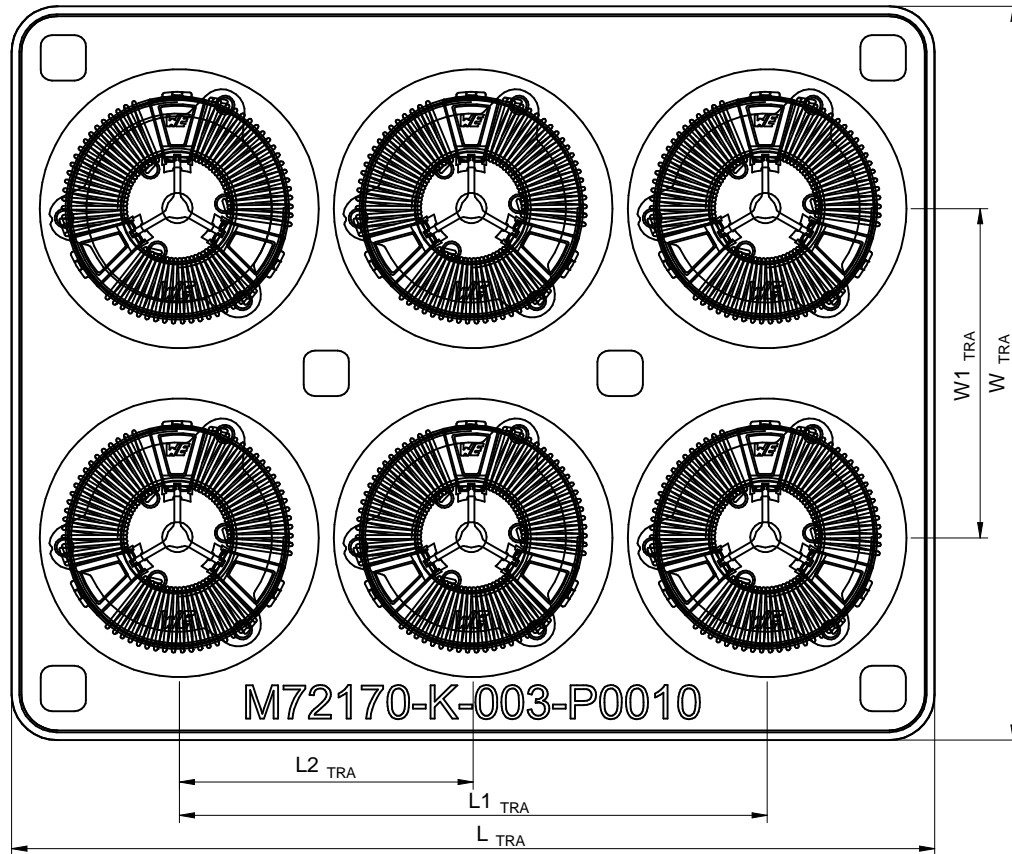


Typical Insertion Loss:



Storage Conditions:


