Differential Mode

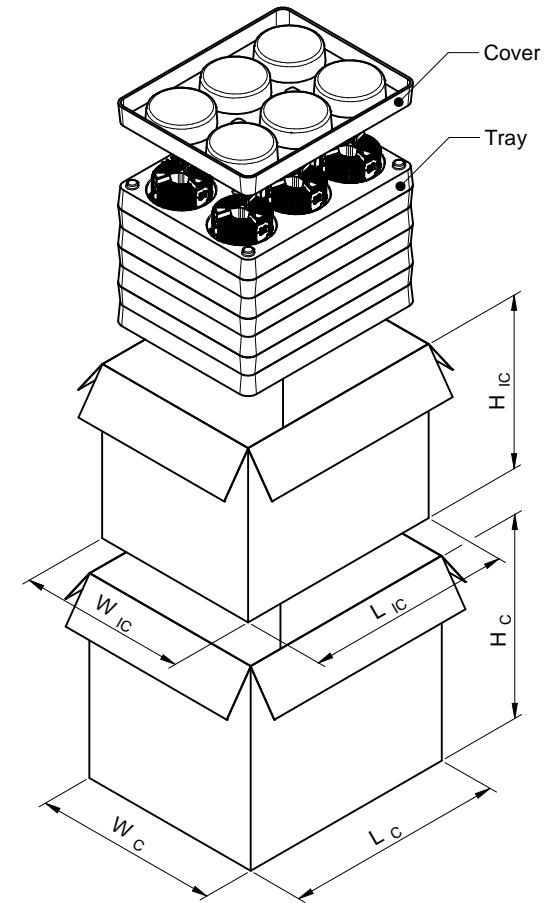
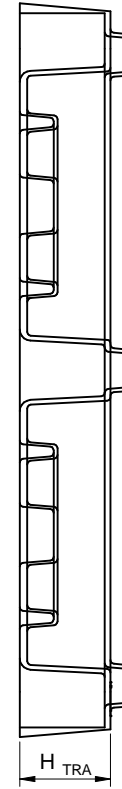
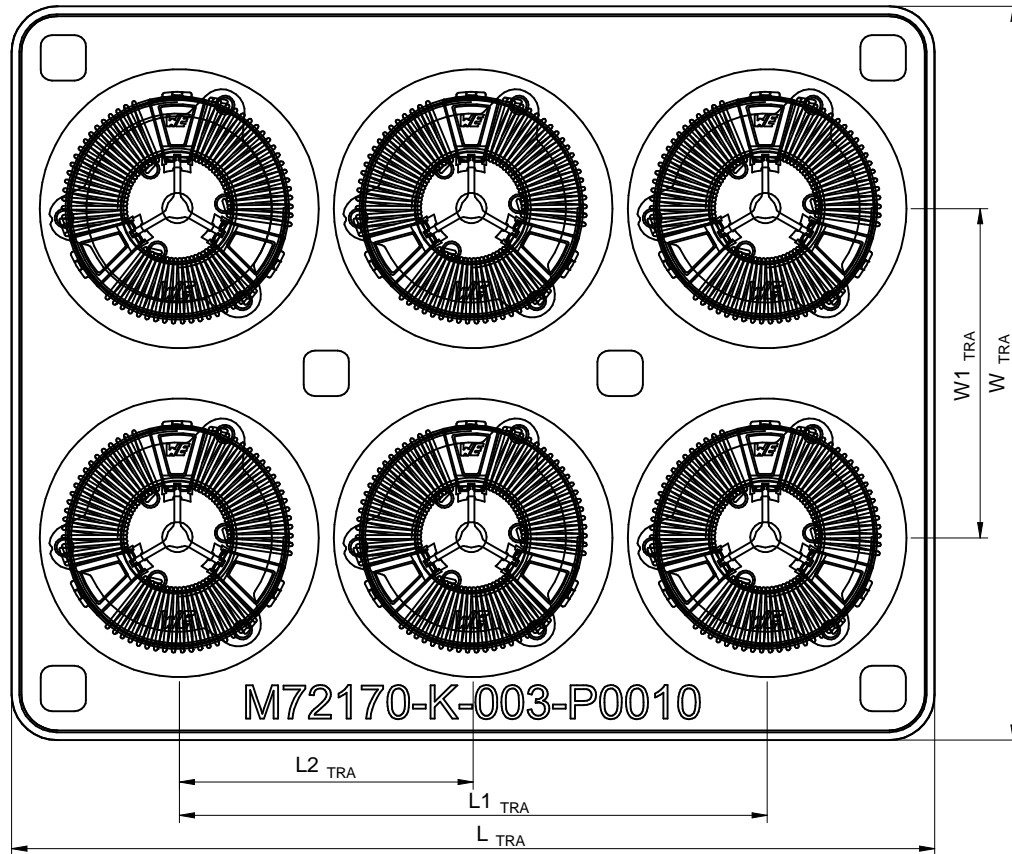


Typical Insertion Loss:

Soldering:



Storage Conditions:


