## Overview

The purpose of this notification is to communicate that Xilinx is discontinuing Defense-grade (XQ) Virtex® FPGA SMD products. This product discontinuance notice (PDN) applies to **Defense-grade XQ (N)** temperature grade products.

## Description

Xilinx assembly suppliers are discontinuing their assembly line as these packages are no longer viable for production in the industry. There are no compatible replacements for these affected part numbers. Customers are encouraged to place a last time buy to support their lifetime demand.
