1 General description

The 74LVC1G06 provides the inverting buffer.

Input can be driven from either 3.3 V or 5 V devices. These features allow the use of these devices in a mixed 3.3 V and 5 V environment.

Schmitt-trigger action at all inputs makes the circuit tolerant for slower input rise and fall time.

This device is fully specified for partial power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing a damaging backflow current through the device when it is powered down.

The output of the device is an open drain and can be connected to other open-drain outputs to implement active-LOW wired-OR or active-HIGH wired-AND functions.

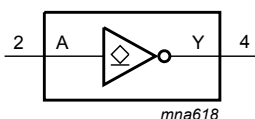


Figure 1. Logic symbol

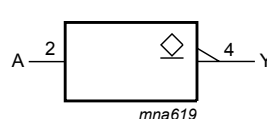


Figure 2. IEC logic symbol

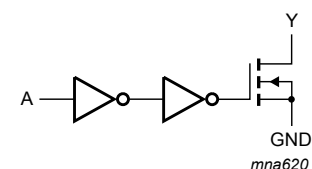


Figure 3. Logic diagram

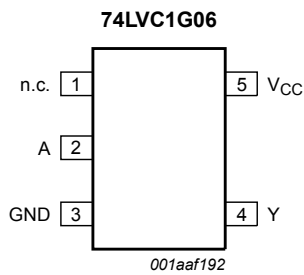


Figure 4. Pin configuration SOT353-1 (TSSOP5) and SOT753 (SC-74A)

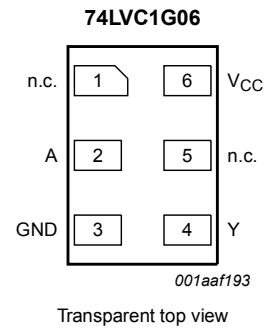


Figure 5. Pin configuration SOT886 (XSON6)

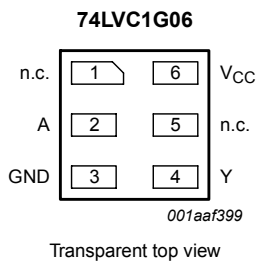


Figure 6. Pin configuration SOT891, SOT1115 and SOT1202 (XSON6)

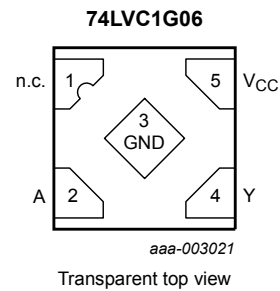


Figure 7. Pin configuration SOT1226 (X2SON5)

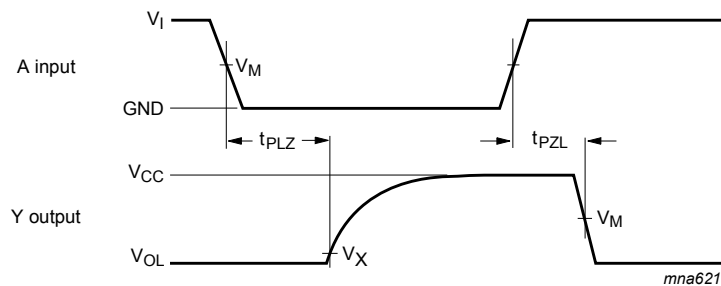

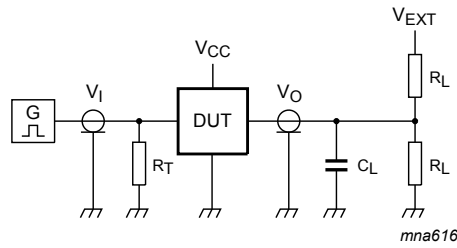

Figure 9. Test circuit for measuring switching times

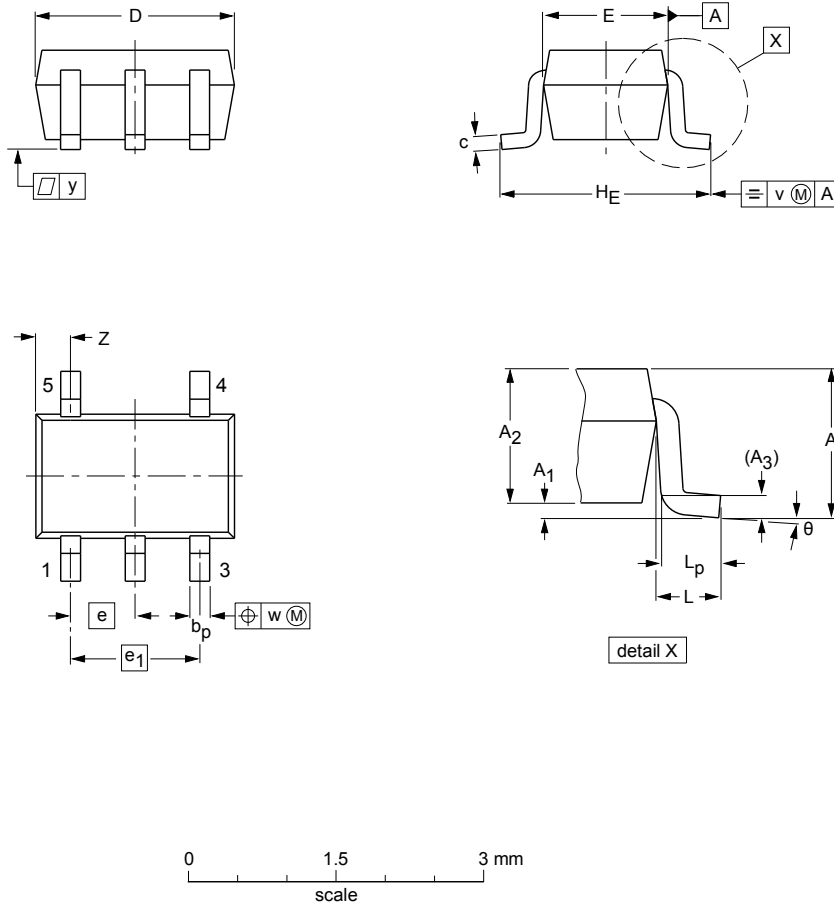

Figure 10. Package outline SOT353-1 (TSSOP5)

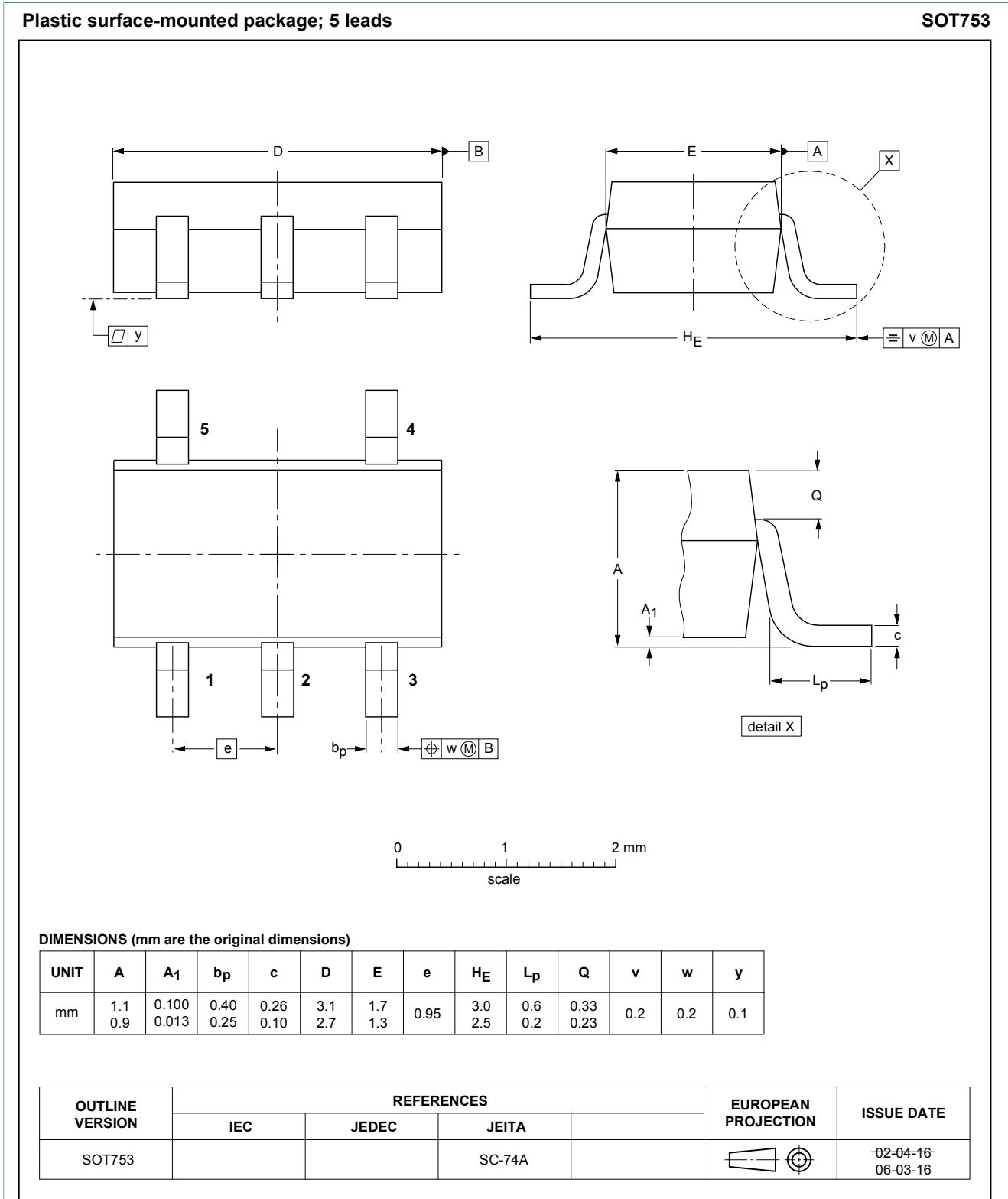


Figure 11. Package outline SOT753 (SC-74A)

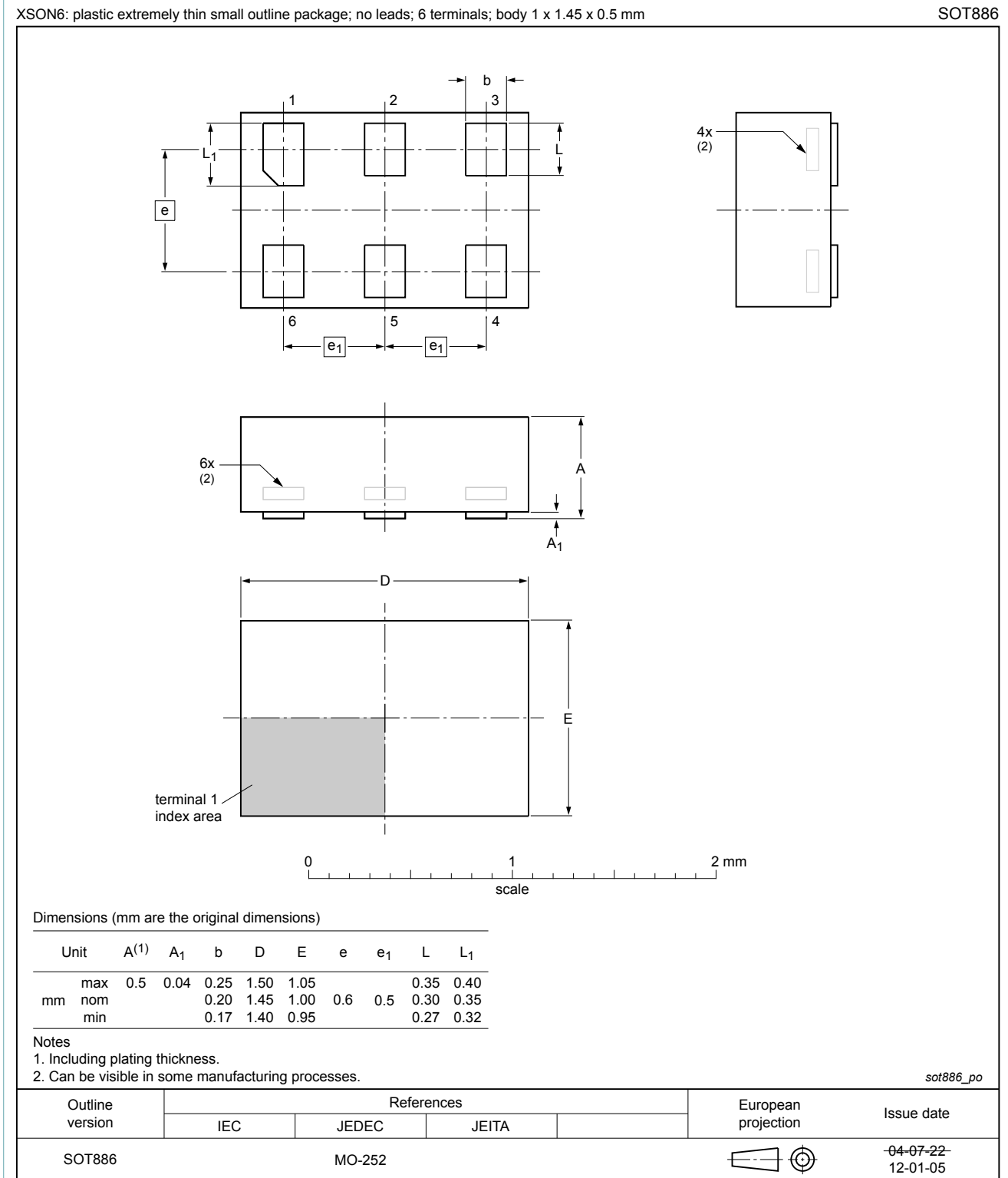
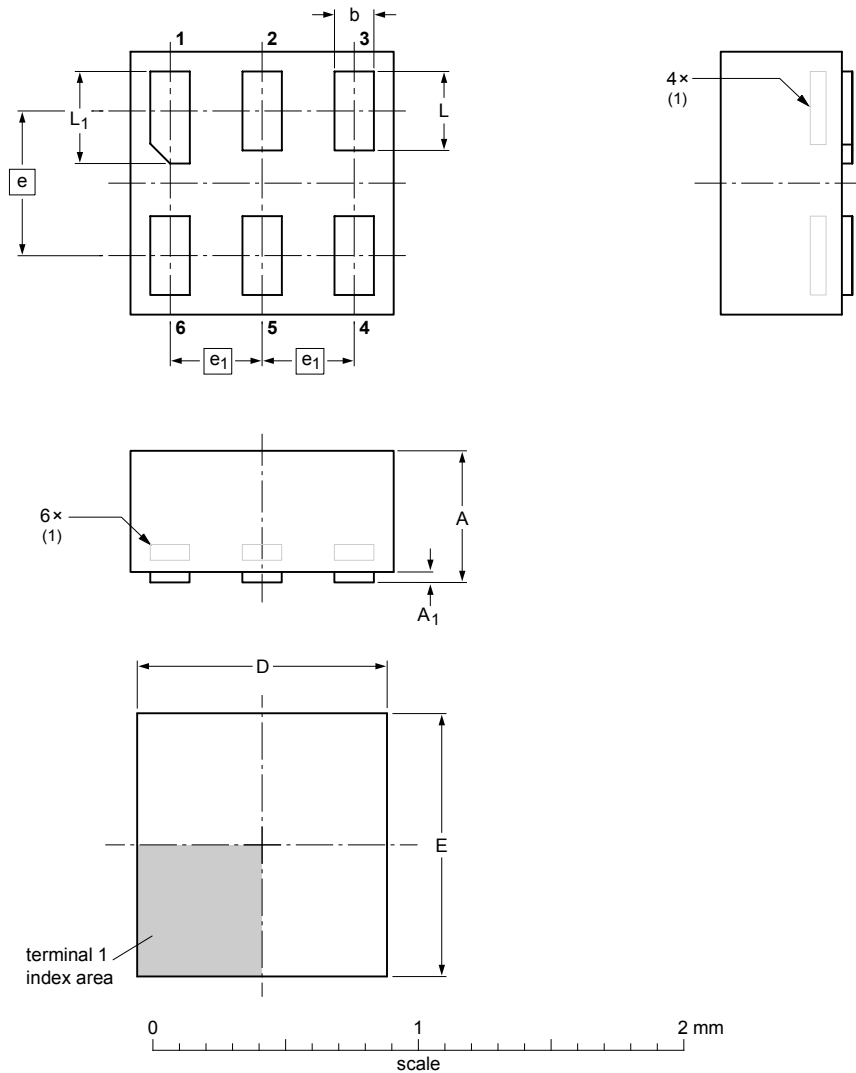


Figure 12. Package outline SOT886 (XSON6)

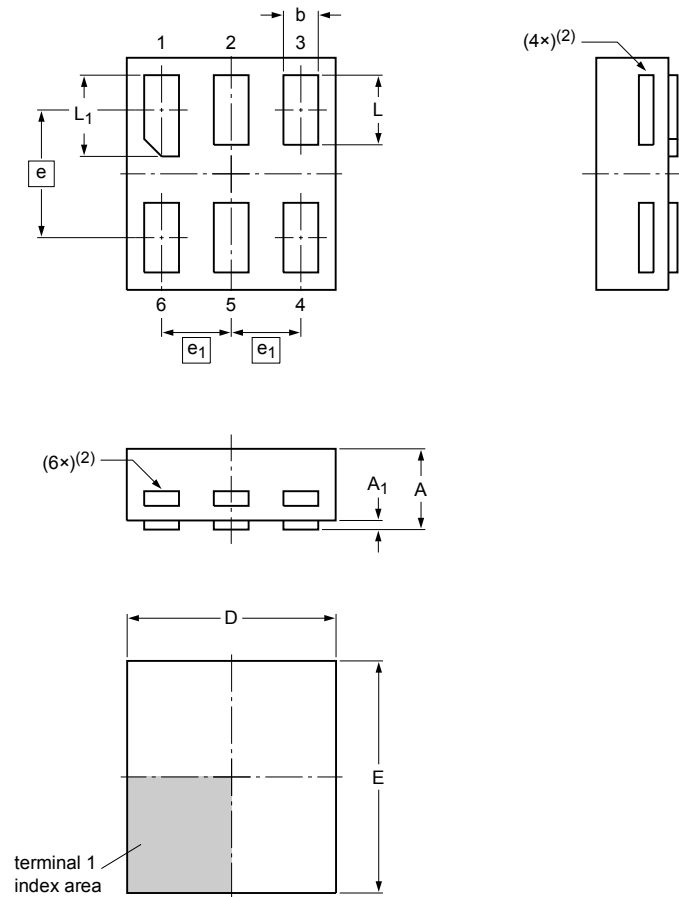

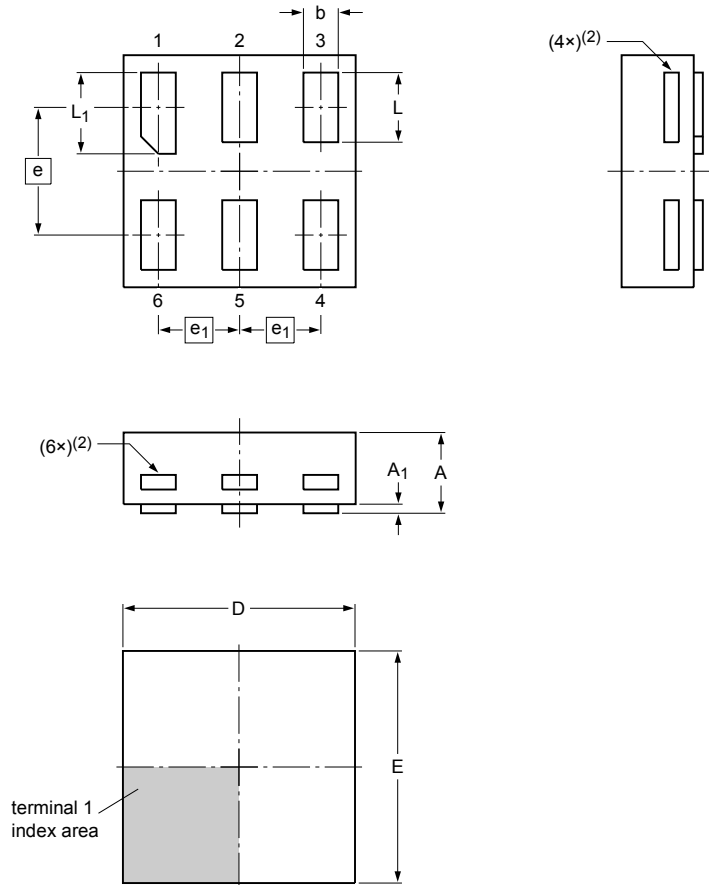

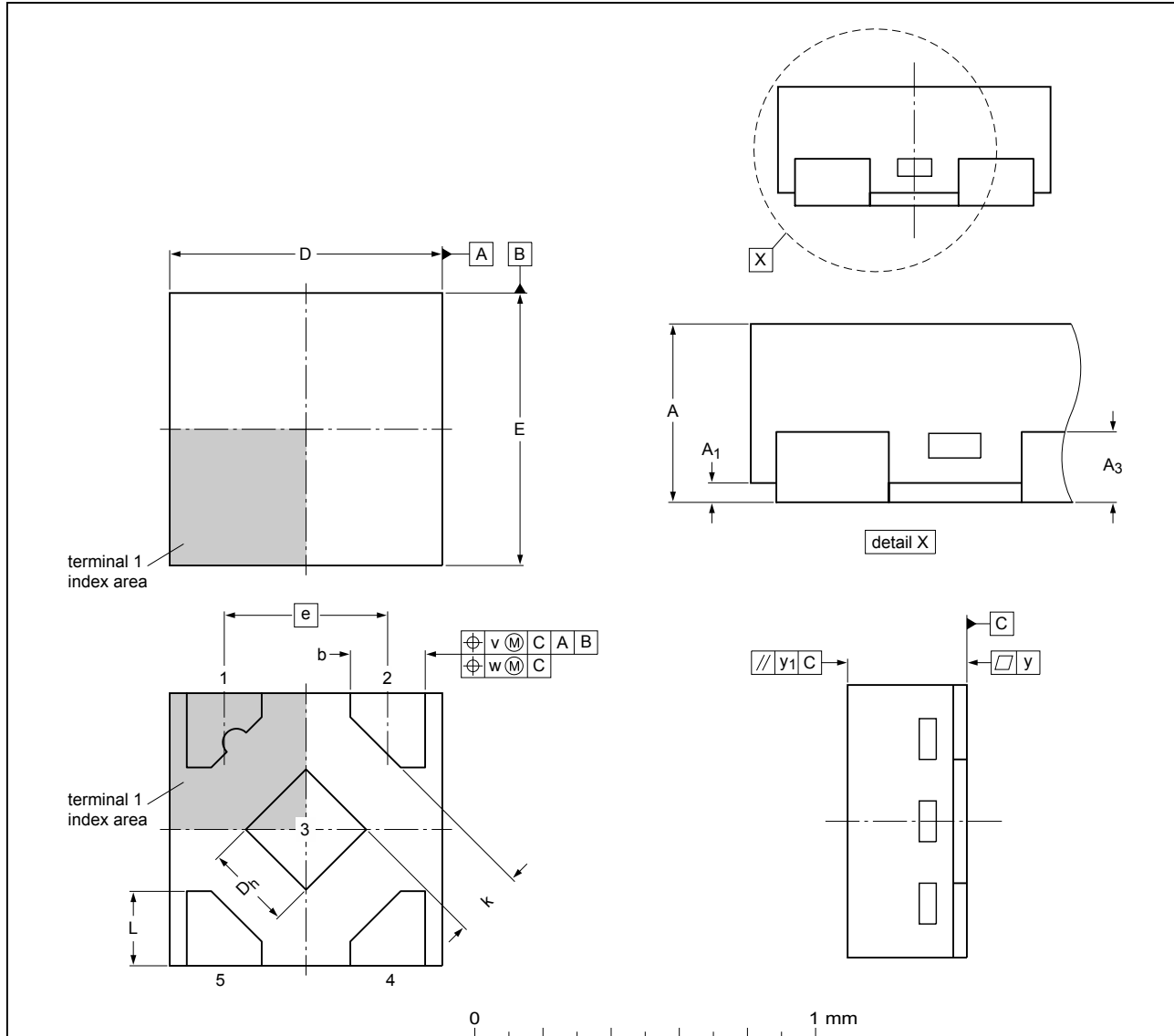
