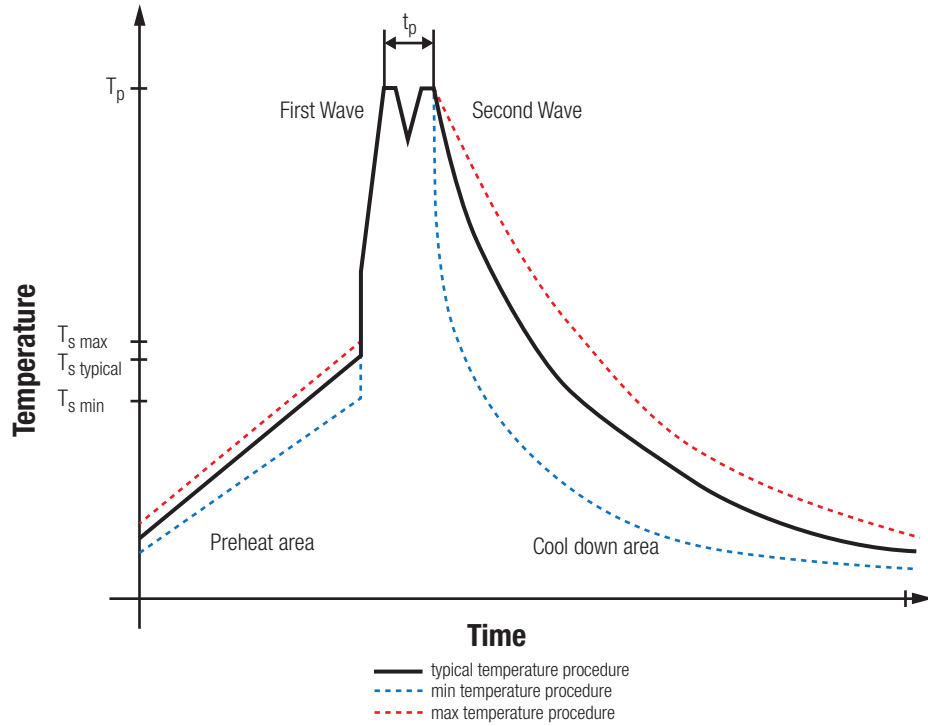



## Storage Conditions:


