Production volume are not enough to maintain the production in reasonable OSE.</li> </ol> <p>Given the reasons above, OSE has decided to EOL the listed packages. For the single source packages, OSE will support customer's product transition to other service sites and also the last buy until June 30, 2019.</p> <p>OSE will continue support customers on our selected packages. We will continue production and will be more focus. Besides if there is any new opportunities that OSE can support especially</p>

on the new developing FCBGA and QFN, we definitely will support.
