Discontinuation of Metral Receptacle Right Angle, Electrical Enhanced

Nature of Change:

Mid nineties demand for signal speed increased for Metral leading to "Metral Electrical Enhanced" (Metral-EE). These building blocks were the entrance to Metral High Speed, a full new sub-family in the Metral range capable of handling speeds up to 5Gbps. Rapidly designs picked-up the High Speed family and Metral EE lost interest. With applications coming end of life, FCI will withdraw the EE-Receptacle Right Angle building blocks (65745-series and 85847-series.).
