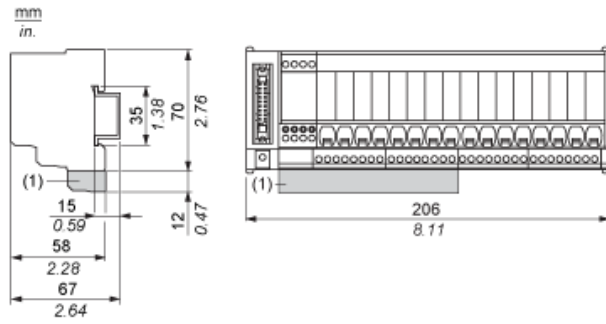

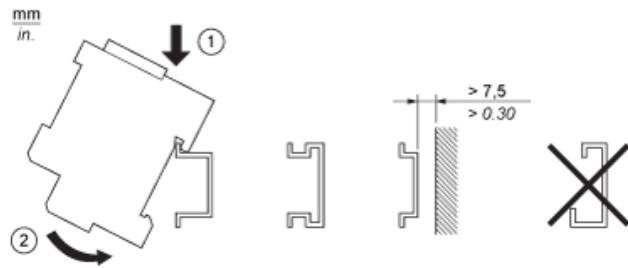

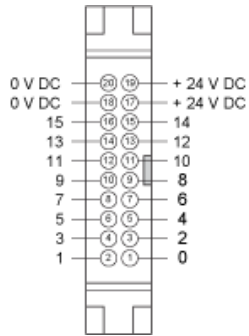

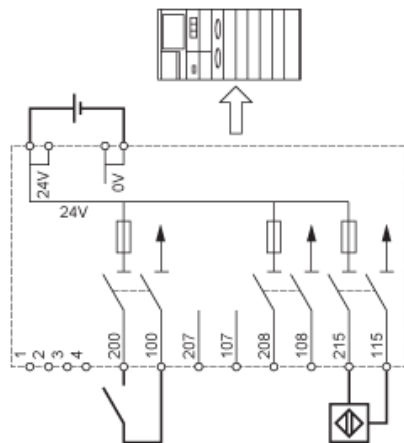

## HE10 16 Channels

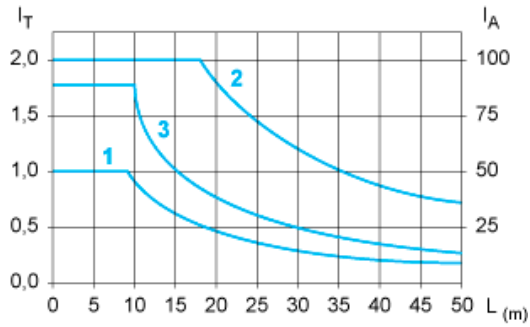


## Wiring Diagram
