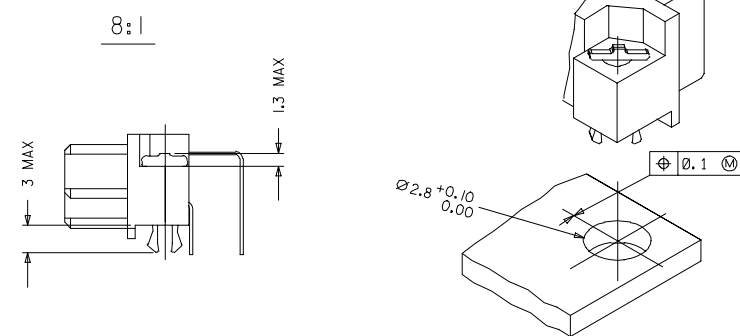
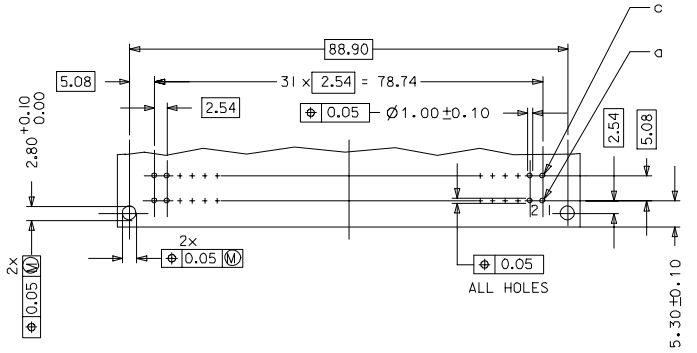

1. PERFORMANCE LEVEL 1: SELECTIVE GOLD (Au), THICKNESS = 1.1 MICROMETER OVER NICKEL, THICKNESS = 1.25 MICROMETER
2. PERFORMANCE LEVEL 2: SELECTIVE GOLD (Au), THICKNESS = 0.6 MICROMETER OVER NICKEL, THICKNESS = 1.25 MICROMETER

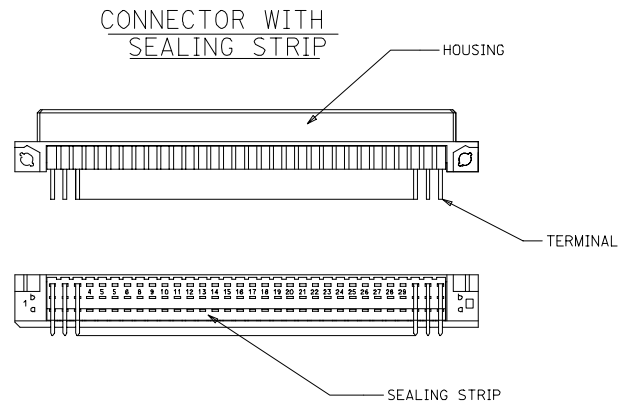
RECOMMENDED PCB LAYOUT
