### Why do I need Safety Services?

- OSHA's industry-wide standard CFR 29 1910.147 control of hazardous energy lockout/tagout program requires each employer to establish an Energy Control Program (LOTO)
- National Fire Protection Agency (NFPA) standard for electrical safety, 2012 NFPA 70E, requires employers to assess the workplace and determine safety related work practices by using both shock hazard analysis and arc flash hazard analysis
- Globally Harmonized System (GHS) of Classification and Labeling of Chemicals is a new standard for defining the physical and environmental hazards of chemicals. Employers are required to train all employees on the new label elements by December 2013 and to comply with all modifications by June 2015.
